1.	Water Testing Status	 A June water test was not possible since the water was so low that access by boat was not possible. ALMS was notified and NELS will do testing later in the open water season.to make up the deficit. First test will take place July 31st Subsequent monthly tests will happen through September, and possibly into October 	 Karen to assist Bob in the data gathering Bob to send samples and data sheet to ALMS Bob to check with ALMS with questions regarding the interpretation of the procedure for data gathering and sample testing
2.	Willow Staking	 West Spring planting to improve aesthetics, provide habitat and eventualy act as a deterent to cars trying to access the lake Harvest 2.0 to 3.0 ft long ¾ to 1.0 inch diameter branches from local willow bushes during the dormant season and then soak in water for 5-7 days. Plant stakes to create new 	 Karen et al to collect willow branches in advance and soak for one week. Karen to advertise this as a volunteer educational opportunity. 3.	Leaf and Grass Collection Area	 The current collection point for grass and leaves has become an eyesore and is extending South into the garbage bin area. There are no physical boundaries defined. Contacted Alberta Environment and Parks and they consider this is of the scale and character of a Class II Compost Facility This type of facility would require temperature and groundwater monitoring, aeration and a certified operator during operating hours, which is beyond our capability. 	There are several options to consider: 1. Taking all of the material away and starting up a defined collection point that would be monitored and then removed annually 2. Spreading out the existing mound and reclaiming the land. Composting on private property would replace the public land collection area. 3. NELS to consult with the public works committee to assess the options and report back to Council in September
4.	Lodgepole Pine Relocation	The trees need to be relocated this Fall since access to Connie's yard will not be convenient in August.	Connie is contacting an arborist to determine if and when he is available to assist.
5.	GWAS State of the Watershed Report	How can we summarize the results of this report for the Ghost Lake Village. It is important to understand the health of the watershed.	 Bob Miller is on a committee that will be releasing a summary paper in September; pdf's of the document can be distributed to Villagers. Can explore having a GWAS representative make a presentation in the Village in the Fall
6.	Concern about a potential parking area needed to access the proposed new Docks	 From an earlier meeting with the Dock Sub-Committee this spring there was a lack of clarity on whether a new parking area would be required to support operation of the potential new dock location in the west end of the Village. Concern was expressed as to where that parking area might be located (on Village parks and natural areas?), how large it might be and how it would be accessed from existing roads. The natural area adjacent to the new docks could become a parking lot for trailers and vehicles when people access their docks in the new proposed expansion 	Need to set up a meeting with the Dock Committee and the Public Works Committee to understand how they are proposing to handle vehicles at the new site.
